## **Declaration on RoHS Directive** (*R*estriction of certain *H*azardous Substances)

The Directive 2011/65/EU of the European Parliament and of the Council of 8 June 2011 on the restriction of the use of certain hazardous substances in electrical and electronic equipment prohibits the placing on the market of products that contain Cadmium (Cd), Mercury (Hg), Lead (Pb), hexavalent chromium (Cr (VI)) or poly-brominated biphenyls and polybrominated diphenyl ether (PBB/PBDE) flame retardants. The Commission's delegated RoHS (EU) Directive 2015/863 of 31 March 2015 will also be complied.

As an environmentally aware company, Brabender Technologie GmbH & Co. KG has already introduced internal guidelines at an early stage to change over to environmentally friendly processes and materials, so that today the a.m. materials are no longer contained in our products and processes.

Brabender Technologie GmbH & Co. KG hereby declares that our products maximum contain any of the substances listed below according to the limits defined.



- 2. Hexavalent chromium (Cr+6) 0.1 %
- 3. Mercury (Hg) 0.1 %
- 4. Cadmium (Cd) 0.01 %
- 5. Polybrominated biphenyl (PBB) 0.1 %
- 6. Polybrominated diphenyl ether (PBDE) 0.1 %
- 7. Di(2-ethylhexyl)phthalat (DEHP) 0,1 % (\*)
- 8. Butylbenzylphthalat (BBP) 0,1 % (\*)
- 9. Dibutylphthalat (DBP) 0,1 % (\*)
- 10. Diisobutylphthalat (DIBP) 0,1 % (\*)

All products are manufactured in compliance with the RoHS Directive which states that:

In the sense of Article 4 (1) and (2) as well as Annex II a maximum concentration value of 0.1 % by weight in homogeneous materials for lead, mercury, hexavalent chromium, polybrominated biphenyls or polybrominated diphenyl ether and of 0.01 % by weight in homogeneous materials for cadmium shall be tolerated.

(\*) The restriction of DEHP, BBP, DBP and DIBP applies to medical devices, including in vitro diagnostics, as well as monitoring and control tools, including monitoring and control tools in industry, as of July 22, 2021
